


## 01 SURVEY SCOPE




## By when will the passenger market be back at 75% of the pre-COVID-19 level?






## On what level will the new "normal" in passenger travel volume settle in the medium term?





# Will COVID-19 change the attitude of the traveler towards flying in the medium to long term?





# How will end-of-2020 aircraft values compare to end-of-2019 values?



#### Where do you see the oil price in 12 months?









