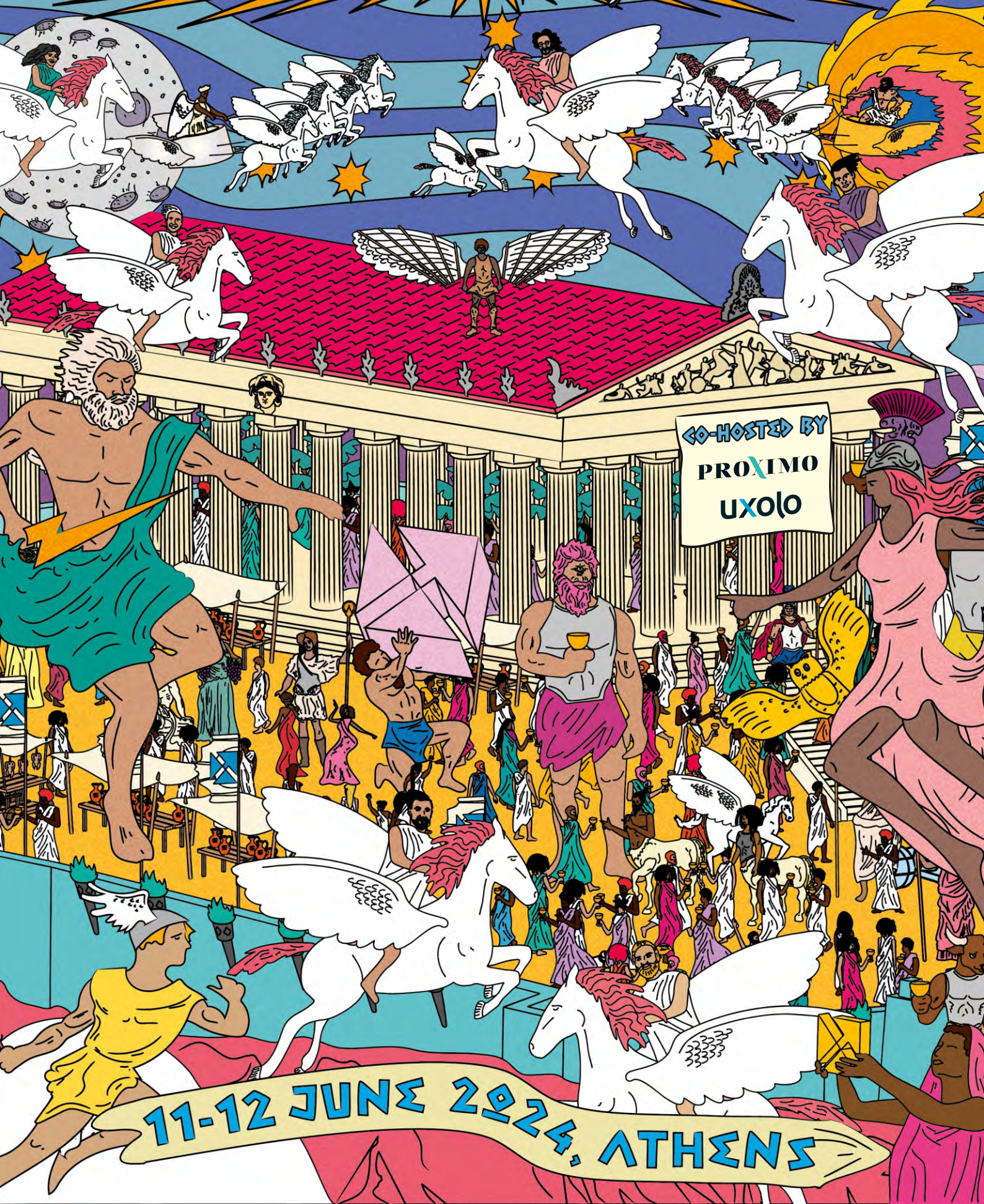

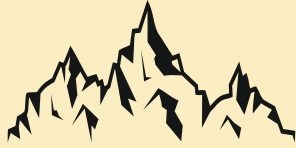

### The Agora: Export credit stream

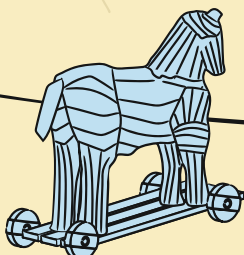
